Voluntary Income	Cash donations over $\pm 50$ are individually listed, those under $\pm 50$ are totalled
Voluntary Help	Voluntary help is not included in the accounts. FOSMAS is entirely dependant on the voluntary help given by parents and staff
Non Cash Donations	Donations of goods other than cash (eg items donated to the Summer Fair) are not included in the accounts. However the proceeds of the sale of these items are shown as incomes
Expenditure	All expenditure incurred within the period is included in the Income and the Expenditure Account. Expenditure committed but for which invoices have not yet been received is excluded but is identified in the notes of these accounts

The Summer Drinks Party, was a great social success; popular with parents and teachers alike. A beautiful evening in the gardens of Fr Gillian, many thanks to him and to Victoria Chandor and Lisa Jones who headed the team who organised this well attended event.

Our main fund raiser of the year was the Summer Fair.
